The Chamber View

July has just flown by and it looks like August could be a blur as well. At the beginning of the month, I was part of a group that included county and city officials that headed to Washington DC to continue the push in having the US Army Corps take responsibility for their share of the roughly \$12m to recertify the local levee system. We met with White House officials from the Office of Budget and US Army Corps. To be honest, that wasn't the best meeting as we still heard from the Army Corps that they're still not convinced that this is their responsibility.

Let me provide a point of information on why we're talking to Army Corps about funding for the levee. When the Army Corps builds a levee, they pay for the entire project but turn over all operational and maintenance responsibility to the local community to pay. That's why out of the \$12m we're expecting to need to cover about \$8m. However, there's a portion of the repairs that are considered a structural deficiency which was done when the Corps initially built the levee. There are two I-Walls along Lycoming Creek near Memorial Avenue that are the main issue that we contend is the Corps' responsibility. The remaining sections of the levee were constructed using the proper technology which are called T-Walls. Will save you

going into the engineering of a levee but if you want more detail, feel free to go online and you'll find all the information about it.

Anyway, the base situation that we're dealing with is that US Army Corps is not taking responsibility for the portion of the repairs that is their responsibility and we're not going to let them off the hook for this one. The cost to repair the structural deficiencies is around \$4m. However, US Army Corps would only need to pay about \$2.6m of that since there's a state grant program that will cover the rest of it.

While in DC, we also met with Congressman Fred Keller, and staff from both Senator Casey's and Toomey's offices. Congressman Keller is very understanding of the issue and brought in an aide from another Congressman's office who is chairing an effort to get funding in place for levees across the country. Senator Casey's staffer was new to our efforts but was attentive to the details we provided. Our last meeting was the most helpful though in our discussions with Senator Toomey's staffer. We've met with him previously and he shared that he's met with Army Corps staff on three separate occasions in trying to address our issue. He provided us with great insight as to the faulty reasoning the Corp is using to deflect their addressing this for

our community. With that knowledge we are putting together a strategy that will hopefully put to rest this issue and get Army Corps on board to take care of the structural deficiency associated with our levee.

Looking ahead to Au-

gust, it definitely is an ac-

tive time for us here in Ly-

coming County. It starts off with the first weekend up at the Loyalsock Valley Antique Machinery Show and wraps up with the Drum Corps World Championships. In between there's a whole host of activities going on here in our community. August 6th is National Night Out which is a great opportunity for all residents and businesses to get to better know their neighbors to keep a watchful eye out on their part of the community. August 8th and 9th is the celebration of the 50th anniversary of public transportation here in our area. Bill Nichols and his team at River Valley Transit provide a great service to those needing transportation services and will be highlighting this milestone with various activities culminating with Midtown Men at the Community Arts Center on August 9th. Also on August 9th is the annual Bottles and Brew event at the Thomas T. Taber Museum which I can personally attest to is one of the best community beer tastings in the area. The following week the Little League World Series kicks

off with the Grand Slam Parade on the 14th and with the start of games the next day. Williamsport Welcomes the World is the following week on August 23rd and we head into Championship weekend on August 24th and 25th. The Chamber will be hosting through funding assistance from the First Community Foundation and Lycoming Economic Development Foundation our third year of hosting site consultants for a familiarization tour of Lycoming County. This is something we do in partnership with the Department of Community and Economic Development at the state and provides us to meet

one-on-one with those that play a key role in determining site locations for industry looking to expand or relocate. After closing out Little League, we quickly switch over our welcome messages to greet the corps and fans of the Drum Corps World Championships that will be taking place. In addition to all of that, you've got students coming back to both Lycoming and Penn Colleges along with students going back to school. And I know there's got to be even more that wasn't even mentioned. All is good though so hopefully you'll find something that is of interest to get you out of the house in August.



United Way focuses on helping more people each year

Since starting in 1922, the Lycoming County United Way has been serving and funding community based programs that focus on a multitude of issues that impact our community on a daily basis. Ron Frick, CEO and President, alongside Brittany Fischer, vice president community impact, work to serve Lycoming, Tioga and Sullivan counties creating opportunities for programs to positively impact health, health education, and financial stability for citizens in the community.

"United Way is an umbrella organization," Frick said. "It deals with the most critical human service needs, working through community partners. Our goal is to fight for health, health education and financial stability for every person in the community.

In the close community of Lycoming county, there are 27 different programs being funded though UW and the programs are being delivered through 23 different organizations.

"Specific to this area, there are programs stemming from emergency situations for shelter purposes," Fischer said. "For women coming out of abusive situations, all the way down to education items where we work in early education with child care programs."

Other programs exist at local libraries and within local schools that are all community impact and or health based. The money that is donated to the United Way is directly

given to said programs to provide the program with the resources they need. The investment doesn't go through the organization or agency.

"I think that's what sets us apart; when people are wondering what is the value of giving to us (United Way) that we are administering their money to that program not the agency," Fischer said. "Knowing that our money is directly impacting how that program operates:

without us there's a chance that some of them would not be available as resources in the community."

"Generally it's through mobilizing community resources, community partners, marketing assets, whatever it takes to mobilize the existing resources in the community to improve people's lives or to create new resources if they don't already exist," Frick said.

The United Way has a new energy and goal to continue to help more people in the community each year by funding more programs and giving back as much as they can.

"We have a new staff, a new energy and we are working towards getting more creative with our approach that way," Fischer said. "We are engaging people in an annual day of action, we just had one in June. We are connecting organizations and volunteers for a hands on approach; it opens their eyes and gives a reason to volunteer."

An on-going goal United Way has set is geared towards the community understanding of what the organization does, how they fund, who they fund, and how they impact the community through time. Give, volunteer, and advocate are three main attributes to the organization as they hope to bring on-going positive impacts and change to Lycoming, Tioga, and Sullivan counties through the organization.

"You can give time, financial resources, expertise, etc., you can volunteer, and advocacy learn about what we do," Frick said.

"Change is slow, change is hard: We are working through and shock-waving how we have done things and I think that seeing people find understanding in that has been rewarding," said Fischer.

"Our job is to figure out how to make the community work together in the best way that we can," Frick said. "We have to work together, together we can change lives."

Appreciative Strategies helps businesses stay fresh

Though a place of comfort, the most dangerous thing a business can do is remain stagnant, according to Dennis Gilbert, of Appreciative Strategies LLC.

Since 2007, Gilbert has worked with a multitude of organizations to develop their workforce and develop strategies for improving their functioning.

"Businesses, of any kind, are usually looking for that spark, that motivation of why should we change," he said. "I help them discover where to go, I don't tell them where to go."

Gilbert got his start as a computer programmer where he led a \$35-million-per-year technology business.

"I had learned a lot about business through them, which was a great experience," he said.

Then he worked for Pennsylvania College of Technology in an administrative role, where he led training groups. Eventually Gilbert moving forward into developing his own business around consultation.

Today, he is an author and certified public speaker through the National Speakers Association. Utilizing five books, most recently #CustServ: The customer service culture, he travels throughout the country to speak to businesses and strategize for long-term goals.

"(Employers) want people that can help them see the positivity, to making a difference, to make some kind of change," he said.

Many employees are worried that any changes will affect their job security, but the change is necessary to stay competitive and thereby keep their job, said Gilbert.

For example, those in the healthcare industry, such as nursing homes, may need to adapt quickly to anticipate or adjust to new regulations.

"I'll help businesses think differently, and open their minds to new opportunities, to make changes and decisions, through strategy and strategic planning," he said.

Gilbert examines what those in the industry call SWAT, or strengths, weaknesses, opportuni-

(From Page D8) ties and threats. All business naturally have areas where they are strong, but Gilbert said they should work to improve their workforce by developing it.

Another aspect of Appreciate Strategies is working with young clients to take over a business, in what he calls succession coaching, which is common in more rurally adjusted such areas Williamsport.

"We're helping someone more junior grow up in the organization to take over a senior position and become the new CEO," he said.

These type of maneuvers are more common in smaller sized "mom and pop stores," said Gilbert.

Whatever the future goals may be however, now may be the time to implement a strategy to achieve them. When the economy is doing well, businesses of all sorts have the opportunity and available resources to invest in new ways to become competitive, said Gilbert.

"Change is somewhat of an overused word, but that's the brutal truth of the day," he said. "There are some people who get hurt in that boom, but largely, the clients that I see are feeling pretty optimistic about it."

Tiadaghton Farm gives events a unique setting

Saying "I do" in front of one's closest friends and family is perhaps one of the most memorable moments for any couple. And when it comes to gorgeous wedding venues in the area, brides- and groomsto-be have a variety of options, from luxurious banquet halls to scenic parks to lovingly decorated and intimate farms.

Tiadaghton Farm, 707 River Road, Jersey Shore, has been the backdrop for over 60 events since 2015, including many weddings, proms, retirement parties, sweet 16 parties, graduation parties, an album release party, baby and bridal showers, class reunions and even the Jersey Shore Chamber of Commerce Summer Picnic.

But owners Rusty and Michele Rozenberg were not interested in entering the wedding business at first. "We reluctantly agreed," said Michele, when a contractor who was remodeling the farmhouse asked if his daughter could get married on the property in 2013. However, even after the cake was cut, the Rozenbergs' foray into the wedding business was far from over.

For a year and a half after the event, they received messages from numerous people inquiring about having their ceremonies and receptions at the farm, said Michele. In August 2015, Rusty and Michele relented, and the first official Tiadaghton Farm wedding was held. "The setting is unique and has a lot to offer with a picturesque farmhouse, stately black walnut trees, manicured grounds and a unique barn," said Michele, of Tiadaghton Farm, the property of which first came into the Rozenberg family's hands in the late 1940s.

Henry and Mary Rozenberg, Rusty's grandparents, purchased the farm, located a mile away from where the Fair Play Men, who were squatters in the eighteenth century, declared their independence from Great Britain in 1776 at The Tiadaghton Elm, said Michele. Originally a tobacco barn built by Henry, Tiadaghton Farm was then inherited by Rusty's parents, Russ and June Rozenberg, in 1990, who then passed it down again to its current owners, Rusty and Michele, in 2012.

Tiadaghton Farm attracts couples from all over the world. Notably, a young man born and raised in South then Africa. attending Pennsylvania College of Technology, attended a wedding reception at Tiadaghton Farm and spent a good deal of time inquiring with Michele about the property's history. "We get people from all over the country that thoroughly enjoy the property, the setting and the beauty of the mountains in the background," said Michele. In the case of Tiadaghton Farm, though the scenery might look like a million dollars, the Rozenbergs are committed to keeping the price affordable.

"(We) do everything we can to ensure their event goes smoothly," said Michele, who



adds each bride brings their own stunning creativity to the barn that makes their event as unique as the last. Tiadaghton Farm also offers couples flexibility in terms of vendors. "Tiadaghton farm does not have any exclusive vendors," said Michele, "This allows brides to have more control over their expenses, and we find that most utilize local businesses." Tiadaghton Farm's business approach helps stimulate Jersey Shore's economy.

Michele has been active with Williamsport/Lycoming Chamber of Commerce since graduating from the Leadership Lycoming program in 2006, having served on the program's operating committee as well. Being part of Williamsport/Lycoming Chamber of Commerce has gained Tiadaghton Farm beneficial network contacts, access to valuable economic information, public exposure and opportunities for training, said Michele.




