

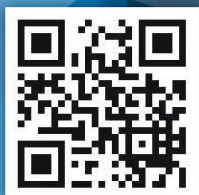

## Lycoming County Visitors Bureau Announces 2023 Travel and Tourism Application Deadline

The Lycoming County Visitors Bureau is pleased to announce the return of the Lycoming County Travel and Tourism Grants program. The revised program is being brought back since we last awarded grants in 2020. Grant applications are available January 6 and are due to the Lycoming County Visitors Bureau by 11:59pm on February 15, 2023.

Funding is to assist with non-profit organizations in their travel and tourism related activities and is to be used for un-

derwriting the expense of promotional and publicity initiatives by those assets for the purpose of increasing tourism within Lycoming County. Awards are granted on a competitive basis. Grant funding is limited to non-profit organizations and preference will be given to the assets that demonstrate the ability to attract patrons from outside Lycoming County.

Organizations meeting the criteria for the grant are strongly encouraged to apply for this funding. Applications and guidelines may be obtained

by going to the Visitors Bureau website, [www.visitlycomingcounty.com](http://www.visitlycomingcounty.com), or the Chamber's website, [www.williamsport.org](http://www.williamsport.org). They can also be obtained by calling the Chamber at 570-326-1971.

Since 2000, the Lycoming County Visitors Bureau has granted out through this program over \$1.7 million to 54 non-profit organizations conducting travel and tourism related events and activities here in Lycoming County.

## The WorkCenter keeps workers safe, healthy

The WorkCenter provides occupational health and safety services to businesses throughout northcentral Pennsylvania.

With five locations in the UPMC network, the WorkCenter establishes employee and workplace health programs specific to a business or industry and offers a range of services and assessments for hiring employees, treatment of injured workers, and other employer needs.

Occupational health and its services have become increasingly in demand.

“People are becoming more aware of the value of their employees,” Chandra Spring DeWald, employer outreach/occupational health coordinator, said. “The Occupational Safety and Health Administration (OSHA) is evolving with the times.”

It’s all part of keeping workers healthy, safe, and productive.

“We are the longest continuous Occupational Health facility in northcentral Pennsylvania,” DeWald said. “We are able to maintain a personal relationship with all our clients.”

The WorkCenter’s client base totals more than 1,500 employers

The personal touch, DeWald feels, has helped the WorkCenter grow.

The range of occupational health services include assessment and care of musculoskeletal injuries, lacerations, and eye injuries.

Employees with serious injuries are to first be seen in the emergency department with possible follow-up care at the WorkCenter.

“The majority of what we do is drug testing,” she said.

A large focus on the need for government-mandated alcohol and drug testing for employees of various industries came following a 1987 train accident that claimed the lives of 19 people. A subsequent investigation revealed that two engineers had been under the influence of drugs.

“That was a wakeup call for the nation,” DeWald said.

The following year, the first WorkCenter was established at Muncy Valley Hospital. The WorkCenter at Divine Providence was established several years later.

The Divine Providence clinic is situated in the hospital’s main building, occupying rooms formerly hous-

ing Sports Medicine and has six exam rooms.

The WorkCenter includes Workers' Compensation injury management for diagnosis, treatment, and management of injured workers.

Trained health care professionals work with employees with the goal of helping them return to work safely. The care is based on standards of the American College of Occupational and Environmental Medicine and compliant with the state Department of Labor and Industry.

The WorkCenter's trained professionals can screen for health conditions to assess a potential worker's ability to perform a job and avoid workplace injuries.

Worker physicals can be done pre-employment, yearly, or to assess an employee's ability to return to work.

Audiometric testing performed at the WorkCenter monitors hearing acuity of an employee. The testing is required by OSHA for anyone worker exposed to 85 or greater decibels of noise in the workplace.

A series of tests known as respiratory clearance evaluate the pulmonary status of employees who are in workplaces contaminated by harmful dusts or vapors. The testing includes spirometry breathing, fit testing for determining the seal between the respirator's face piece and employee's face, and blood tests.

The WorkCenter's mobile unit can come to employers to perform on-site testing for substance abuse, medical surveillance, and employee physicals.

Education is also a big part of the WorkCenter's mission.

"We help companies navigate rules under OSHA," DeWald said. "I spend a lot of my time talking to employers."

DeWald noted that six Department of Transportation agencies make use of UPMC's WorkCenters. They are: the Federal Transit Administration, the Federal Railroad Administration, the Federal Aviation Administration, the Federal Pipeline and Hazardous Materials Safety Administration, the Federal Motor Carrier and Safety Administration, and the U.S. Coast Guard.

In addition to Divine Providence and Muncy Valley, UPMC WorkCenters are in Wellsboro, Lock Haven, and Coudersport.

## Hope Enterprises gives diverse community meaning, purpose

Hope Enterprises has spent over 70 years serving an often neglected population of Lycoming County.

“Our staff has always provided high-quality services to people with disabilities,” said Rob Labatch, president and CEO.

Staff at Hope Enterprises, 2401 Reach Road, have promised to continue with that commitment in 2023.

Over the next year, Hope will continue to grow the organization and serve its mission of enhancing lives.

Hope employees do this to remove any false stereotypes of those they serve.

Hope was founded in 1952 by physician Dr. Max E. Miller, and his wife, Leona, as well as other parents and community leaders in Williamsport.

From the start, the organization was a front runner in providing community services to people with intellectual disabilities.

Families were faced with the care of their special needs children, but no community services were available for them.

The only options were to keep their children at home or place them in an institution.

That didn’t happen because of Dr. Miller and his wife who considered this community with its diverse and varied abilities and special needs their lifelong commitment to service.

In the early years Hope provided classes for children and adults with diverse abilities.

Over the years, Hope expanded to assist their families with securing medical services, companion services and guidance and then

spotting any missing areas or gaps in families’ needs.

Hope established group homes, training and vocational services and workshops.

Today, Hope recognized through its decades of service that the needs of these families were greatly varied — “there are all unique needs — they’re all different,” Labatch said.

The successes Hope has seen

stem, in part, from “always listening to what people’s needs and their wants are, what they need out of a service,” he said.

In 2023, Hope will:

- Lend an ear to its workforce, team members and the individuals who are supported.

- Listen closely to the community for what it needs and then act on this feedback.

- Empower those in need in the

community.

- Seek out and create new opportunities for people, new partnerships.

“Developing partnerships to support community inclusion is the future of Hope’s services,” Labatch said.

Another of the Hope management also believed the future success depends on partnerships.

“By pairing the needs of our

community with the interests of those we support, we will continue to build relationships that are meaningful and beneficial to all,” said April Shimel, director of CHOICE Services.

Enhancing the lives of people with intellectual “disABILITIES,” by providing them with caring support and responsive services,” is what will take place in 2023 and beyond.

## The Barn is a venue 'too beautiful not to share'

The Barn at Pine Creek, located at 4729 North Route 44 Highway, Jersey Shore, is a rustic, mid-1800s barn in Pine Creek Valley that can be rented out for weddings.

The venue, owned by husband and wife Tim and Cami Mahaffey, has been renovated to fit the needs of wedding guests.

"We fell in love with the spot, a farmhouse on 10 acres with tons of creek frontage and a large barn. It is such a cool spot that we'd like to share it — It's too beautiful not to share," she added.

"It was rundown, and my husband and I had looked at it a couple of times. I was like, this would be a beautiful spot for a wedding venue. That was the vision we had, to just get into something different," Cami Mahaffey, Owner of The Barn at Pine Creek said.

"We restored the house from top to bottom and kept the barn as rustic as possible," she added.

Guests that rent out the venue have access to the location from Friday to Sunday. Along with the barn, there is a house next door that has rooms available for the wedding party.

The venue provides guests with tables and chairs and has newly renovated bathrooms included in the barn.

"There's two rooms in the house that the wedding party use to get ready prior to the wedding, the girls have a suite and the guys have a sweet," Mahaffey said.

Guests of The Barn have creative and financial freedom over their wedding planning as they are responsible for booking food, decorations, music and so on.

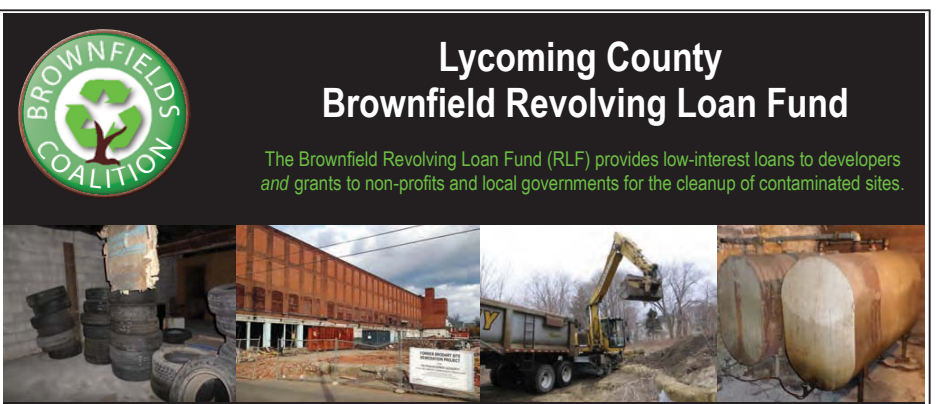

## Lycoming County Brownfield Revolving Loan Fund

The Brownfield Revolving Loan Fund (RLF) provides low-interest loans to developers and grants to non-profits and local governments for the cleanup of contaminated sites.

### RLF Overview

The Lycoming County Revolving Loan Fund Program, funded by an \$800,000 U.S. EPA award, makes loans and grants available for site remediation and subsequent redevelopment. The goal of the program is to return Lycoming County Brownfield sites to productive use. Lycoming County has led a brownfield program since 2005 and has inventoried over 80 sites and conducted over 30 site assessments through its program.

- Site monitoring and data collection
